<u>Old Business</u>: <u>Quinnesec Water Holding Tank Roof</u>: A pavilion-style roof over the holding tank was just one of the possible ways to address some of the systemic challenges for maintaining the integrity and longevity of the tank. Therefore, seeing as the roof project was not a DEQ requirement, nor a mandatory remediation effort and because the construction cost is so high, the recommendation is to postpone awarding the bid for the Quinnesec Water System holding tank roof while more options are explored.
