The meeting was called to order by Supervisor Olson at 7:00 p.m.

<u>Roll Call</u>: Present: Trustees Soderbloom, Johnson, Rochon, Wales, Treasurer Taylor and Supervisor Olson. **Absent:** Clerk Neuens- excused.

Pledge was recited by all.

Public Comment: No comments.

<u>Approval of Agenda</u>: **Motion** by Trustee Wales, **second** by Trustee Rochon to approve the November 26, 2018 Agenda as presented. **Vote: Unanimous, motion carried.**

<u>Approval of Minutes</u>: **Motion** by Trustee Soderbloom, **second** by Trustee Johnson to approve the November 12, 2018 Regular Board Meeting minutes with correction. **Vote: Unanimous, motion carried.**

<u>New Business</u>: <u>Proposal 1 – Recreational Marihuana</u>: As a local unit of government we cannot regulate or prohibit recreational marihuana use as long as the individuals are in compliance with the Act. However, we can regulate or prohibit recreational marihuana establishments through an ordinance.

After a lengthy discussion a **motion** was made by Supervisor Olson and **supported** by Trustee Soderbloom to schedule a public hearing on January 14, 2019 at 7:00 p.m. for an ordinance that will prohibit marihuana establishments. **Vote: Ayes:** Trustees Soderbloom, Wales, Rochon, Treasurer Taylor and Supervisor Olson. **Nay**: Trustee Johnson. **Motion carried**.

<u>Budget Amendment 2-2018</u>: **Motion** by Trustee Wales, **second** by Trustee Rochon to approve Budget Amendment No. 2-2018, in the amount of \$8,500 to cover the cost of the new back-up Election Equipment. **Vote: Unanimous, motion carried.**

<u>Establish the 2019 Budget Public Hearing Date</u>: **Motion** by Trustee Rochon, **second** by Trustee Wales to hold the 2019 Budget Public Hearing on December 10, 2018 at 7:00 p.m.

Vote: Unanimous, motion carried.

<u>2019 Meeting Schedules Resolution</u>: **Motion** by Trustee Wales, **second** by Trustee Soderbloom to approve Resolution No. 11262018-A, a Resolution to Establish the 2019 Meeting Schedule.
