

**BREITUNG CHARTER TOWNSHIP
DICKINSON COUNTY, MICHIGAN
ORDINANCE AMENDING CHAPTER 93 HEALTH AND SANITATION**

ORDINANCE NO. 2019-082619a

At a meeting of the Board of Trustees of Breitung Charter Township, Dickinson County, Michigan, held at the Breitung Charter Township Hall on August 26, 2019, at 7:00 p.m., Township Board Member Richard Wales moved to introduce the following Ordinance for a first reading prior to posting, publication, and subsequent final adoption, which motion was seconded by Dave Soderbloom:

An Ordinance to amend the Breitung Charter Township Code of Ordinances to promote the health, safety, and welfare, by prohibiting the accumulation of junk, rubbish, and trash; and repealing all ordinances or parts of ordinances in conflict with this ordinance.

BREITUNG CHARTER TOWNSHIP, DICKINSON COUNTY, MICHIGAN, ORDAINS:

SECTION 1. AMENDMENT TO CODE OF ORDINANCES CHAPTER 93, SECTION 93.03: The Breitung Charter Township Code of Ordinances Chapter 93, Section 93.03, is amended to read as follows:

§ 93.03 STORAGE OR ACCUMULATION OF JUNK, RUBBISH, OR TRASH PROHIBITED.

It shall be unlawful for any person to store, or to permit the storage or accumulation of junk, rubbish, or trash.

SECTION 2. SEVERABILITY: The provisions of this Ordinance are hereby declared to be severable and if any provision, section or part of this Ordinance is declared invalid or unconstitutional by a court of competent jurisdiction, such decision shall only affect the particular provisions, section or part involved in such decision and shall not affect or invalidate the remainder of such Ordinance, which shall continue in full force and effect.

SECTION 3. REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.


SECTION 4. EFFECTIVE DATE: This Ordinance shall take effect the day following publication and posting after final adoption by the Township Board.



Please take notice that on August 26th, 2019, the Township Board of the Charter Township of Breitung introduced for first reading, posting, publication, and subsequent final adoption Ordinance No. 2019-082619a, which amends Chapter 93 to prohibit the accumulation of junk, rubbish, and trash.
